




**Chris Flavin**  
President, Worldwatch Institute

Chris Flavin is a leading voice on the potential for new energy technologies and strategies to replace fossil fuels—increasing energy security and avoiding dangerous climate change. He is co-author of three books on energy, including “Power Surge: Guide to the Coming Energy Revolution”, which anticipated many of the changes now underway in world energy markets. His two decades of energy research and writing encompass solar energy, wind power, bio energy, geothermal power, energy efficiency, and hydrogen. He is a regular co-author of the Institute’s annual State of the World report, which has been published in 36 languages. Chris Flavin is a founding member of the Board of Directors of the Business Council for Sustainable Energy and serves as a board member of the American Council on Renewable Energy, the Climate Institute, the Institute for Global Environmental Strategies, and the Environmental and Energy Study Institute.

**Nicky Gavron**  
Deputy Mayor of London

As the Deputy Mayor, Nicky Gavron plays a key role in London government. She has responsibility for the environment, strategic planning and children and young people. She led for the Mayor in preparing the London Plan. In particular, she promoted sustainable design and construction including the Supplementary Planning Guidance for all new London developments. She also set up and now chairs the Hydrogen Partnership for London. Nicky Gavron is now leading for the Mayor on climate change, including implementation of the London Climate Change Action Plan, the establishment of the London Climate Change Agency and the setting up of the C40 - large cities climate leadership group. She is an elected member of the London Assembly and the only Deputy Mayor of London.



**Dr. Ashok Khosla**  
Chairman of the Development Alternatives Group

He is also co-Chair of DESI Power Pvt Ltd, a company dedicated to delivering energy services to village communities in rural India, and President a.i of the Club of Rome. His previous positions include being the Director of the Office of Environment for the Government of India, followed by a position as Director of Infoterra in the United Nations Environment Program. He has been a Member of the Governing or Advisory Bodies of the World Economic Forum in Davos, IUCN, WWF, IISD, the Stockholm Environment Institute, WETV, EXPO 2000 and several other international organizations. He was Special Advisor to the Brundtland Commission and Chairman of the NGO Forum at the ‘92 Earth Summit in Rio de Janeiro. Ashok Khosla studied at the Universities of Cambridge and Harvard. He was awarded the Stockholm Challenge Award in 2002, the UN Sasakawa Environment Prize in 2002 and the Schwab Foundation’s Award for Outstanding Social Entrepreneur in 2004.



**James P. Leape**  
Director General, WWF International

James P. Leape joined WWF International as Director General in December 2005. Mr Leape has worked in nature conservation for more than 25 years. He began his career as an environmental lawyer, working on environmental protection cases in the United States, advising the United Nations Environment Program (UNEP) and co-authoring a text on environmental law. He joined WWF-US in 1989 and for ten years directed its worldwide conservation programs, serving as Executive Vice President. From 2001-2005, Mr Leape directed the conservation and science initiatives of the David and Lucile Packard Foundation, one of the largest conservation funders in the world.



## **Armory B. Lovins**

**Chairman and Chief Scientist, Rocky Mountain Institute**

Amory Lovins, a MacArthur Fellow and consultant physicist, has advised the energy and other industries for more than three decades as well as the U.S. Departments of Energy and Defense. Published in 29 books and hundreds of papers, his work in 50+ countries has been recognized by the "Alternative Nobel," Onassis, Nissan, Shingo, and Mitchell Prizes, the Benjamin Franklin and Hapold Medals and many others. He advises industries and governments worldwide, and has briefed 19 heads of state. In 1991 he invented the technology which permits cost-effective manufacturing of the ultralight-hybrid Hypercar® vehicles. His 28th book "Small Is Profitable", an Economist book of the year, was published in 2002, and his Pentagon-cosponsored 29th book, "Winning the Oil Endgame" in 2004.



## **André Schneider**

**Managing Director and COO, World Economic Forum**

André Schneider is currently Managing Director and Chief Operating Officer of the World Economic Forum, and the member of numerous committees. Prior to this he worked as a researcher in parallel computers for the European Community, followed by employment as Product Developer, Consultant and then Principal at IBM Consulting. His career however started in music, based on his studies as a classical Orchestra Musician and his experience from the Richard Strauss Conservatory in Munich. He played for the Philharmonic Orchestra of Berlin, the Kassel City Theatre, the Symphony Orchestra of the Radio Saarland and the Lucerne International Festival Orchestra. He cemented his interest in computers with a PhD in Computer Science, University of Geneva.

## **Klaus Töpfer**

**Former General Director of the United Nations office in Nairobi and Former Executive Director of the United Nations Environment Programme**

Klaus Töpfer studied economics in Mainz, Frankfurt and Münster. In 1968 he earned his doctorate at the University of Münster. After working as government official, professor and adviser on development politics he became the Minister for the Environment and Health in the regional government of Rhineland-Palatinate in 1985. In 1987 Töpfer became the German Federal Minister for the Environment, Nature Conservation and Nuclear Safety under Chancellor Helmut Kohl. From 1994 to 1998 he served as Federal Minister for Regional Planning, Civil Engineering and Urban Development. He was a member of the Lower House of Federal Parliament (Bundestag) from 1990 to 1998 and a member of the Steering Committee of the Christian Democrats political party from 1992 to 1998. In 1998 Töpfer was appointed Under Secretary General of the United Nations, General director of the United Nations office in Nairobi and Executive Director of the United Nations Environment Programme.



## **Prof. Ernst Ulrich von Weizsäcker**

**Dean, Donald Bren School of Environmental Science and Management**

Currently Dean of the Donald Bren School of Environmental Science and Management, UC Santa Barbara in the USA, Ernst von Weizsäcker has enjoyed a long career in research, politics and academia. He is a member of the Club of Rome, the European Academy of Arts and Sciences and the World Academy of Art and Science. He has also written several books, including "Limits to Privatization" (together with O. Young and M. Finger) and "Factor four. Doubling wealth – halving resource use" (coauthored with A. & H. Lovins). His previous academic positions include being the Professor of Biology at the University of Essen (1972) and President of the University of Kassel (1975). From 1981 he was the Director of the UN Centre for Science and Technology for Development in New York. This was followed in 1984 by work as Director of the Institute for European Environmental Policy, and in 1991 he became the President of the Wuppertal Institute for Climate, Environment, Energy. In 1998 he was elected as a Member of the German Parliament for the Social Democratic Party (SPD), where his knowledge was put to use as Chairman of the Select Committee on Globalization, and later of the Environment Committee.
